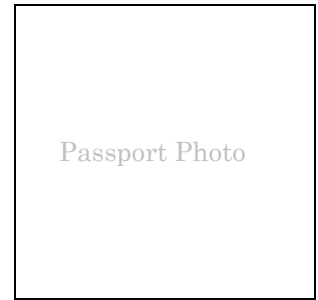
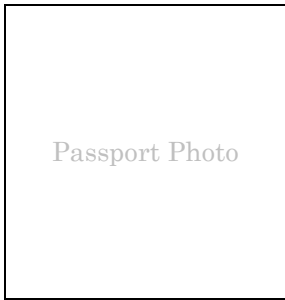

The Immigration Regulations, 1997 (Regulation 12)

APPLICATION FOR A VISITOR'S PASS

IMPORTANT

1. A visitor's pass shall expire if holder thereof
 - a. Is found to be prohibited immigrant.
 - b. Engages in any pursuit in the United Republic other than that specified on such pass as being the purpose for which the holder was permitted to enter the United Republic.
 - c. Fails to pay deposit which may have been required to him as a condition of the granting of such Pass.
2. A person who, being the holder of a Visitor's Pass, engages in employment without permission in writing of the Director of Immigration Services, shall be guilty of an offence and shall be liable on conviction to a fine of fifty thousand shillings or to imprisonment for a term not exceeding 18 months, or to both such fine and imprisonment.
